Mayor Hendricks called the meeting to order and introduced the Town Council, Town Attorney and Town Manager. He then spoke to the citizens about the Town Council's deliberations on annexing the Fox Run Subdivision, Windtree Subdivision, and adjacent properties.

Next he introduced Police Chief Boyd Veal. The Chief presented to the audience the services that would be provided by the Signal Mountain Police Department.

The Mayor then introduced the Fire Chief John Vlasis. Chief Vlasis spoke to the citizens about the fire fighting, emergency medical first response and hazard materials mitigation services by the Signal Mountain Fire Department.

After that presentation, the Mayor introduced the Public Works Director Loretta Hopper. The Director spoke to the audience to explain the services that would be provided by the public works department staff for garbage, leaf and brush collections, street repairs and maintenance, recycle services, snow removal and salting of streets, and other services that would be provided.

Next the Mayor introduced Recreation and Parks Director Jarred Thompson. He spoke to the audience and outlines the various services that would be provided in the recreations facilities and non-residents fees that would no longer be paid.
