Mayor Hendricks called the meeting to order. The Mayor turned the meeting over to Councilmember Annette Allen.

Dr. Richard Urban spoke on the e.coli pollution in Bee Branch, Shoal Creek and Short Creek and the causes. He talked about failing septic tanks and drain fields and the illegal installation of straight pipes that bypass septic systems.

Next Dr. John Tucker talked about the impact that impaired streams have on the health of the citizens and ecosystems.

Than Gary Picket, with the Hamilton County Health Department spoke on septic systems and the problems with limited soil on the mountain.


Henry Hoss with the Hamilton County Water and Wastewater Treatment Authority discussed additional sewers on the mountain.
